Dear Members of the TRANSFORM Family,

TRANSFORM Country Results 2022

In 2022, a total of 31 TRANSFORM applications (including T0Ts) were conducted in 15 countries in Africa and the Arab region.

Earlier this year, for the first time, a survey was sent out to all host agencies to assess the impact of the trainings and the application of the learnings within the country or institution over a longer period of time. We received responses from 8 countries, showing significant results. We have selected.

Most notably, responses showed that in most countries, the action plans created at the end of the training are either fully or partially implemented: see graph 1. Hosts also saw changes at institutional level that they believe came as a result from the participation in one or more TRANSFORM applications (graph 2)

Changes noted included the following:

"Projects within the district conducting joint supervision is a clear sign of improved coordination which is one of the key components of TRANSFORM training package" – Malawi.

"Their understanding of the social registry and its goal has improved, government officials, are now more vocal on life-cycle risks and categorization of social allowances." - Palestine

"Improvement in the complaints and grievance system; Coordination Mechanism of the National Social Protection System strengthened the supervision component and the importance of working in synergy of the different components."- Sao Tome & Principe





A Transform Facilitates the Drafting of the National Social Protection Policy in Zambia

"I enjoyed the financing session the most as it brought out various financing strategies that I hadn't known of." said Florence from Ministry of Community Development and Social Services. "The key message from the session was not to go looking for the money to finance social protection programmes but rather focus on the rights aspects of the beneficiaries and the importance of improving their lives," she added.

In July, 2023, for the first time, TRANSFORM was used as a tool to facilitate for the drafting of the National Social Protection Policy in Zambia. The policy makers module was stretched to cover 5 instead of 2 days, to facilitate the development of the draft revised policy through additional group exercises. One of the major outcomes was a renewed commitment to attempt a legal framework in Zambia. The workshop took on a twin approach, firstly, to widen and deepen the understanding of the concept of social protection among the drafters of the NSPP as well as to facilitate the drafting process.

Using the TRANSFORM training was a unique one-off adapted version that was designed to respond to the specific needs of the NSPP drafting team. Therefore, new activities and lectures were designed for this training such as activities on 'I dream of a country', 'Vision pause', 'graduation to social protection; and a few more. Existing activities in the standard curriculum that were adapted to suit the policy drafting process included the ball juggle and the spaghetti tower to illustrate the importance of building resilient systems that are shock responsive.

The training was well received by all participants, demonstrated by high spirited and energetic discussions as participants actively contributed to interactive lectures and different group activities. One example of an activity that stood out as a highlight included participants using new information gained through various lectures to analyse the social protection delivery systems across various programmes. The analysis culminated in the identification of gaps in the systems and new ideas on how those gaps could be addressed through the process of the policy review and drafting process. The facilitation team comprised three accredited Transform Master Trainers namely; Mutale Wakunuma, Stanfield Michelo (both from Zambia) and Portia Kekana (from South Africa).

For the first time, Cameroon applied the District TRANSFORM curriculum which was modified and translated into French by the 3 Master Trainers: Aly Cisse, Isabela Martins Machado, and Gabriel Fernandez during the preparatory phase. The adaptation was to facilitate the increased engagements of district actors and focused on the local context. This allowed participants not only to better understand certain concepts used, but also allowed them to participate actively in the discussions during the presentations and activities. They were thus able to share experiences from their professional careers.

Participants were active during the sessions with high interest in the activities that were for many 'wow' moments of revelation increased a greater understanding of social protection system generally, and specifically with its implementation in Cameroon. This resulted in their commitment to increase the awareness on social protection and improve implementation at the level of their districts as evidence by the robust Regional Action Plans developed. They also made a commitment for greater collaboration and coordination at both the district and national level.

The overall objectives of this training were to increase awareness and understanding among social protection practitioners and key stakeholders of social protection policy and programs, as well as a key objective to strengthen their capacities to promote coherence between different social protection programs to improve the governance, coordination and administration of social protection programs in Cameroon.

ILO Cameroon through the KOICA project "**Empowering women for resilient** economies and peaceful communities in the East and Adamawa regions in Cameroon", brought together 5 districts from Northern Cameroon for a District level TRANSFORM training in Ngaoundére, Northern Cameroon.

At the end of the training each participant defined their short-, medium- and long-term actions that they would implement on their return to their place of work in their district.

"I shared the training with my colleagues, and my office decided to run a massive campaign to register entrepreneurs in urban and rural areas for social security, thereby guaranteeing them and their families social benefits in the event of risks incurred in the course of their work. The slogan of my action is 'This is how your light can change the world' ".

INSTITUTIONALIZING TRANSFORM ~ Uganda, Malawi and Zambia

There is a new trend emerging in the TRANSFORM community in East and Southern African countries. Looking to upscale and establish sustainable capacity building provision in social protection targeting government staff at national and sub-national levels, governments and partners increasingly focus on strengthening in-country Social Protection education within public learning institutes.

TRANSFORM is a partner in these efforts in a number of countries and works with government and development partners towards adoption of learning materials in national context. These processes are led by partners at national level.

In Uganda, TRANSFORM was identified as the preferred training tool to be used as part of the national institutional and capacity development strategy in the social protection sector. The strategy was developed in recognition that Uganda needs to cultivate social protection expertise to meet growing investments in social protection programming across the country. The process of institutionalising and domesticating TRANSFORM is being implemented in a phased manner and will be guided by an institutionalisation roadmap. One of the first steps is to identify the appropriate institute within government to take this on.

In Malawi, TRANSFORM partners have reached far-going discussions with Magomero college, a government training institute, interested in building a curriculum on social protection, based on TRANSFORM. A first adaption of materials to the Malawian context has already been made and partners are now looking to finetune curriculum while starting resource mobilization for staff to be trained and the programme to be rolled out.

In Zambia, the government (through the ministry of community development) is working with partners to plan a national level Training of Trainers, aimed at training qualified and motivated public officials in TRANSFORM delivery. This incountry cohort of Master Trainers will be able to play an important role in accelerating the role out of the Single Window initiative in Zambia, which has been combined with TRANSFORM district level trainings. The ToT will not only facilitate a more economic, and large scale roll out of capacity building of social protection practitioners in Zambia, it is also an important milestone towards a government driven and implemented capacity building approach in Zambia.
